## STANDARD TERMS AND CONDITIONS

1. 4 3 3 Transport (Proprietary) Limited (company registration: 2019/153886/07) is a company duly registered in terms of the laws of South Africa ("**4 3 3 Transport**").
2. 4 3 3 Transport only employs the services of drivers that carry Professional Drivers Permits as is required in terms of South African law. Furthermore, 4 3 3 Transport carries comprehensive insurance cover whose premiums are settled timeously on a monthly basis.
3. Notwithstanding anything contained in these Standards Terms and Conditions, the customer acknowledges and accepts that 4 3 3 Transport is only liable for losses suffered by the customer as a result of the gross negligence of 4 3 3 Transport. In the event that 4 3 3 Transport was declared by a court to have acted with gross negligence, then the customer's claim shall be limited to the claim amount that 4 3 3 Transport is entitled to claim in terms of its insurance.
4. The customer acknowledges and accepts that it has a legal duty to always observe the highest standards of safety when being transported in any of the 4 3 3 Transport operated vehicles. The customer further acknowledges and agrees that 4 3 3 Transport shall not be held liable, legally or otherwise in instances where:
  - a. the customer failed to wear and fasten its seatbelt and as a result the customer suffered injuries of whatever nature;
  - b. the customer disobeyed the driver's instruction to close any window for safety purposes (all our vehicles are fitted with powerful air-conditioning systems, therefore there is no reason as to why windows should be opened, this is for safety purposes), and as a result suffered injuries of whatever nature and/or a loss(es) of whatever nature; or

- c. the customer performs any other act that is against any South African law.
